- **a.** Michelle Bachelor to give update on Stand-Down in September: Not going to be holding it, due to COVID. Could not do it while keeping everyone safe & healthy.
- **b.** Michelle Bachelor: Phase 2 of CN's opening will not go into the next phase due to increasing cases of COVID
- c. Lisa Look: Tulsa's Walk-in clinic is still closed due to COVID

- **5.** Consideration and action regarding merging with Southwest COC
 - **a.** Lorinda McDaniel: SW COC has the same software that we do, which will limit technological obstacles.
 - **b.** Their merger plan is due to ODOC by September and should be complete by Sept 2021
 - **c.** Others COCs are in favor of the merger
 - **d.** Elizabeth Adams: Question re: making sure that ID #s aren't duplicated with current clients in our system. Lorinda will look into this.
 - e. Motion made to support the merger: Lisa Look; Seconded by Laura Garner
 - f. Motion carries unanimously
- **6.** Discussion regarding ESG COVID funds
 - **a.** NEOCAA must know if you want to apply today (6/25), because Letters of Support are due from the Lead Agency/NEOCAA tomorrow (6/26)
 - i. The agencies that plans to apply so far: NEOCAA sponsors: Hope House, Community Crisis Center; CARD to sponsor GLMH and Youth & Family.
 - ii. Jennifer Hinson: Grand Nation wants to apply.
 - **iii.** Sherri Sherwood asked what the funds would cover. Sarada thoroughly covered the eligible costs and application process. Sherri Sherwood said that The Ark/FFATC will not be applying.
 - **iv.** Brandy Clopton: Tahlequah Men's Shelter is interested but needs some more information. Sarada and Lindi will provide that.
 - **b.** Discussion re: Funding Amount & how to split the amount
 - **i.** Total: \$733,035.00; 4-Way Split: \$183,258.75; 5-Way Split 146,607.00; 6-way split: 122,172.50
 - ii. Discussion: Not every agency has to accept the full amount; if they want to request, for example, only \$100,000, the remainder of their portion could be split amongst other applicants.
 - iii. Discussion: It's helpful and fair if agencies that are planning to apply present their draft budgets with the total amount they're requesting to their Sponsors by July 1st, 2020, so that allocations can be properly made amongst all applicants.
 - iv. Keila Dewey made a motion to split the total funding amount between the agencies that present their budgets to their sponsors by July 1. Seconded by Brandi Clopton.
 - v. Motion carries unanimously.
 - **c.** Deadline for Applications to NEOCAA: HARD DEADLINE of 4:30 Central on July 8th

- 7. Discussion regarding COVID-19 Coordinated Entry Programs
 - **a.** Natalie Shelton gave summary: This is Notice CPD-17-01. COC needs to make sure that it's not inadvertently discriminating against people through its prioritization process. Natalie has received guidance from ODOC that we need to work collaboratively with our COC to address this.
 - **b.** Lindi Conover-Thompson made a motion to create a COVID Coordinated Entry Committee to address these policies. Josh DeBartolo seconded
 - c. Motion carries unanimously

 - e. Sarada McGaha volunteered Natalie Shelton to chair the committee & Lindi Conover volunteered to co-chair.
