- 5. Committee updates, recommendations, and action items
 - **a.** Planning Committee Chairman Natalie Shelter said the committee would resume their duties after the PIT count is completed
 - **b.** HIC & PIT Committee
 - i. PIT Count takes place this coming Tuesday, January 31. Both Natalie and Denise need the links sent to them from Lindi, so that they can forward it to their teams. Jessica said Northwest Arkansas counties had just finished the bulk of their count on software called "Ipiercein" (sp?). Old Fort Homeless Coalition covers Crawford, Franklin, Logan, Polk, Scott and Sebastian counties in Arkansas. Since we border them, if we have any

c. HMIS Committee, Ashley Benz John Ann gave the report in Ashley's absence. We have served 93 more clients since November. Please run your reports after entry and fix any errors on 6A-6D. The highest error rate has been in income, and lack of annual evaluations. Be sure to complete ROI's.

Natalie moved, and Keila seconded to accept the committee reports as presented. Keila called roll. Adopted unanimously.

- 6. New business

 Denise reviewed the list of meetings for the year, and asked for a volunteer to host the July meeting. John Ann said NEOCAA would do it, if no one else will.
- **7.** Next meeting, February 23rd, 2023. Denise announced the next meeting on Feb. 23rd via Zoom.

Additional comments: John Ann said that ODOC had given TMS and CCC extra CV2 funds because we met our spending criteria. She asked if anyone else in the CoC had gotten funds. Denise said GMHC had asked for \$180,000, but it was found they didn't meet the 75% spending threshold, so the funds were denied. No one else said they received funds.

Natalie announced that TMS has received a B Core grant, which is \$300,000 a year for 3 years. This is the first time this grant has been awarded to them, so they are very excited.

Discussion turned to the desperate need for family shelters in Northeast Oklahoma. There are DV and substance abuse shelters, but no shelters for the people who are simply homeless. The Salvation Army has tightened their requirements for assistance, so that has further hampered clients receiving help. Rent is beyond many client's means, so they may be employed, but still living in their car. Natalie noted that many homeless clients have so many barriers that it is likely they will never qualify for housing.

Keila moved, and Lauren seconded to adjourn the meeting. Adopted unanimously. The meeting was adjourned at 12:30 p.m.
