 - **a.** Jessica provided an overview of the ESG program and the purpose of this public comment.
 - **b.** Purpose of ESG24 Focus Group introduce an initial list of proposed changes to the ODOC 2024 Annual ESG Program and ask for any feedback for items proposed or new ideas that need to be discussed by/for the community.
 - i. Reinstate the policy that agencies cannot return funding.
 - ii. Requesting one volunteer from each COC that has experience with ESG to score other COC applications.
 - iii. Advocates are working with decision makers to improve funding availability. The proposed change is that any applicant that gets 50% or less of possible points are ineligible to receive ESG funds.
 - iv. Any agency receiving a high-risk score 2 years in a row will need to receive training and assistance before becoming eligible again.
 - v. New requirements for sponsor agencies for Tulsa entitlement grantees
 - vi. Foreign language translations: Standardize ESG Client File forms across the state so that the documents can be translated into the appropriate languages. A new system to support verbal translation.
